STUDIO POLICY

1. LESSONS

Lessons are on piano, violin and music theory, and this includes posture, working knowledge of scales, chords and theoretical subjects, technical work, piece analysis and practice skills, repertoire study, performance practice, artistic interpretation, memorisation, sight reading, aural skills and accompanying/band ensemble work. Lesson contents are to be individualised and decided according to students' levels and demands.

2. SCHEDULING OF LESSONS

Lesson times are scheduled at the mutual agreement of teacher and student, subject to the availability of open lesson times. Lessons are given weekly in various time lengths (e.g. 30, 45, 60 and 75 minute).

3. PRACTICE

Regular home practice is essential for student success. Students need a daily, non-interrupted time to practice. Time will vary according to teacher assignments and student levels.

4. PARENTAL INVOLVEMENT

Parental support is crucial for student success. Please help your student to establish and stick to a practice routine and see that practice time is free of distractions. If you are the parent of a young child student, please plan to sit with your child for at least a portion of their daily practice time. The assignment notebook is an effective way of teacher-parents communication about assignments and student's progress.

5. INSTRUMENT REQUIREMENT

All students must own or hire a suitable instrument for practice. The quality of the student's instrument plays a significant role in their potential for success. Acoustic pianos should be tuned at least once a year and kept in working order. If you prefer a digital piano, please invest in a full-size keyboard (88 keys) with weighted, touch-sensitive keys and pedals. Violins and bows must be appropriate for the student's physical characteristics and levels.

6. ATTENDANCE

Students are expected to attend each scheduled week of the term. When you register for lessons, your timeslot is reserved for you for the teaching year. Please keep in mind that the studio thrives to operate at full capacity and make-ups for missed lessons are not guaranteed. No refunds will be given for a missed lesson(s) but the fee for that first missed lesson in a given school term will be credited to next term's lesson fee if a make-up lesson cannot be arranged and only if a notice is given at least 1 day prior to the lesson day (only 1 lesson per term can be missed and the credit transferred to the next term in full). For lessons missed more than once and for all casual lessons where students do not have regular weekly lessons, no attempt will be made to arrange a make-up lesson, nor will the credit be transferred to the next term. Please be prompt – lesson times cannot be extended for students who arrive late. If you should arrive early for your scheduled lesson time, please wait until no earlier than five minutes before your scheduled time before entering the studio. Further, please be prompt in picking up your child after his/her lesson if you must be absent during that time. Each student is entitled to his/her privacy during lessons-please work to extend to one another this very important courtesy.

7. PAYMENT

There are certain guidelines to which I adhere regarding payment of lesson fees. These guidelines are consistently maintained and cannot be altered as they allow the business portion of music lessons to flow smoothly and equitably. Lesson fees are reviewed regularly and thus subject to increase when deemed necessary.

These are flat fees to reserve your, or your child's, weekly time for lessons, whether you choose to attend or miss. **Fees are charged by the school term.** All fees for lessons are due the commencement of the first lesson in each new term. Payment is to be made electronically by bank transfer.

8. MISSED LESSONS AND "MAKE-UPS"

The studio shall not assume any financial responsibility for a student's absence(s) due to illness, weather, sports, etc if the absence is more than once per term. It is highly recommended that you attend regularly during the school terms and summer session if any lesson is scheduled. If, for some reason, a lesson must be missed, please notify me immediately. Regular attendance of lessons is an issue of responsibility and choice on the part of parents and students. Again, the studio shall not assume any financial responsibility for student's absence(s). The studio shall, however, assume financial responsibility should the teacher become ill, be out of town, or cancel for any reason. a make-up lesson for the missed lesson will be scheduled as soon as possible or the lesson fee will be credited to the next term's lesson fee.

9. SUMMER MONTHS

During the summer school vacation period, lessons may be provided but for a limited period of time. The exact dates for summer lessons will be announced by the end of each year. Students should expect to continue lessons on at least a part-time schedule through the summer to maintain the skills they develop through the school year. However, there is no obligation for the students to enroll full time.

10. MUSIC

When the need arises, the studio shall determine which music books and supplies should be purchased. Music orders will require shipping, and may take some time. Bills for music will be passed to the parents in person upon the arrival of music if any resources are ordered by the studio. Please pay for the music by the next lesson in cash or bank transfer. When the books cannot be ordered online or when it involves shipping fees, parents are expected to visit music shops to purchase books.

11. PARKING

Please park on either side of the paved area of the driveway. Please do not park in the middle of the driveway to allow another car to be parked next to your car. Please avoid going into the lawn area to prevent damage to sprinklers.

12. GROUNDS

The music studio is part of my private residence and must always be regarded and respected as such.

- -Please remove your shoes as entering the studio.
- -No food nor drink (except water) is allowed in the studio.

13. TERMINATION OF LESSONS

a) By the student

If a student and/or parent should decide to terminate lessons at any given time during the year, the studio requires a four-week written notice. Such notice must be delivered to the teacher via email or text messages. Regardless of when appropriate notice is given, such student/parent shall be financially responsible for the following four weeks, whether the student/parent chooses to attend or be absent.

b) By the teacher

As a music teacher, I support and care for all of my students and their families in a very special way. One-to-one education is very concentrated, and the bond between teacher and student can grow quite strong. Nevertheless, the studio reserves the right to terminate a student's lessons for any reasons the teacher deems appropriate with a four-week notice.

14. MEDIA RELEASE

Photos of students and video and audio recordings of student projects and performances may be posted online and used by the teacher for promotional and workshop materials. Identifying information will be GRACE MUSIC STUDIO
